ALL ISSUES, INCLUDING THE ARBITRABILITY OF A DISPUTE, ARE FOR THE ARBITRATOR TO DECIDE. COMPLETE AGREEMENT





- (20) Clear Shelves
- (16) Dome Head Coarse Thread Screws
- (58) Dome Head Fine Thread Screws
- (6) Flat Head Screws
- (20) Wood Dowels

Additional Tools Recommended:


- An extra set of hands and/or something to initially prop the side panels up against
- Stepladder
- Power Drill with Phillips drill bit (configured to its lowest setting)
- Phillips screwdriver

Step 1: Side Panels




- Stand 2 side panels upright (2 people recommended) and place 3 Dowels into the 1st side panel. Make sure that each pilot hole is aligned before using either a power drill with a Phillips drill bit configured to its lowest setting (recommended) or Phillips screwdriver to screw in (6) Dome Head Fine Thread Screws.
- Repeat this for the 3rd and 4th panel (1 at a time), finishing up by screwing together the 1st and 4th panels together.

Step 2: Inner Baseplates (Top & Bottom)



- While standing on a stepladder (recommended), place an inner baseplate inside of the recessed area at the top of the side panels.
- Align pilot holes before screwing in (8) Dome Head Coarse Thread Screws through the baseplate and into the top of the side panels to secure in place.
- Carefully flip the display upside down (2 people recommended) so that the bottom of the display is now at the top, then affix 2nd inner baseplate into that recessed area using (8)
 Dome Head Coarse Thread Screws.

Step 3: Large Bottom Baseplate



- Place 4 wood dowels into the top of the side panels that match up with the square holes shown above.
- Place large bottom baseplate onto the dowels and screw into place using (17) Dome Head Fine Thread Screws.

Step 4: Bottom Rolling Base


● = Dome Head Fine Thread Screw (Completed in Step 3)

■ = Flat Head Screw (To Be Inserted During Step 4)

Flat Head Screws (6pcs)


- Place bottom rolling base onto the bottom of the display. Turn until the holes line up through the sight hole. Use a screwdriver to screw in the (6) Flat Head Screws.

Step 5: Top Header



- Carefully flip the display back to right side up (2 people recommended), so that the wheels are now on the ground.
- Place 4 wood dowels into the top of the side panels that match up with the square holes shown above.
- Place headers onto the dowels and screw into place using (17) Dome Head Fine Thread Screws.

Step 6: Shelves



- You may now add any or all (20) shelves in whatever configuration you wish along the slots of each side panel.
- Congratulations; assembly is complete and you're all set with your Usborne Woodgrain Spinner Display!
